1. Introduction

1.1 Welcome to FuneralPlanningExperts.com and our related applications (our "Site"). Our Site is owned and operated by Data Locator Group Limited ('we', 'us' or 'our') 'DLG'.

1.2 Please read these terms and conditions of use ("Terms") before using our Site. By using our Site you are agreeing to be bound by these Terms and you are entering into a contract with us to provide you with an introduction to a Funeral Plan provider that may or may not be able to fulfil your requirements.
